## Other Information

**Exams:** Exams will consist of several types of questions (multiple choice, fill in the blank, short and long answers), and will be designed to assess your understanding of lecture materials and ability to apply what you learn to solve problems.

**Critical review:** The review will be a critique of a primary research article published within the last 5 years in a scientific journal. The topic should be related to Endocrinology. Select a research article and read it carefully. Evaluate the significance, originality, and quality of the research. Assess both strengths and weaknesses of the article.

**Presentation:** Each student will do an in class presentation about the research article. Schedule will be posted on Moodle.

## Course Policies

**Missed tests:** Students with a documented reason for missing a test, such as illness, compassionate grounds, etc, which is confirmed by supporting documentation, may request accommodation from the course director. There will be no make-up exam for the mid-term. Instead, the weight of the midterm exam will be transferred to the final exam. Deferred standing for final exam will be granted to students who miss the final exam for a valid reason and submit a request within 3 days of the missed exam. Further accommodation will require students to submit a formal petition to the faculty.

**Assignment submission:** Critical reviews must be handed in during the class on or before the due date to the course director. No email submission will be accepted. The penalty for late submission is 1 point (out of the 15 points) deduction per day. Exception to the lateness penalty for valid reasons such as illness, compassionate grounds, etc, may be entertained by the course director but will require supporting documentation.

**E-mail policies:** Emails to the course director should include BIOL4320 on the subject line and your name and student number at the end of the email. Emails that do not meet these requirements will not be answered.

**Missed classes:** Class attendance is expected. If you miss a class, it is your responsibility to obtain notes from a classmate.
